All you want to know about? EB-5 Immigrant Investment

EB-5 is an investment program where foreign citizens who invest in the United States and create jobs for American workers can get a “Green Card”.

An immigrant investor who invests \$1 Million (or \$500,000 in a target employment area) and creates 10 jobs for American workers can achieve permanent residency for themselves and/or their children under the age of 21.

A US Government approved Regional Center (RC) is a vehicle that has gone through a sort of pre- approval process and makes it easy for the foreign citizen to invest and process all the necessary paperwork. American Dream has a number of RCs in operation.

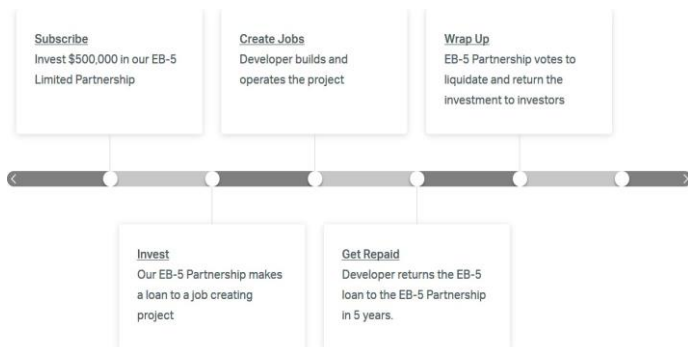

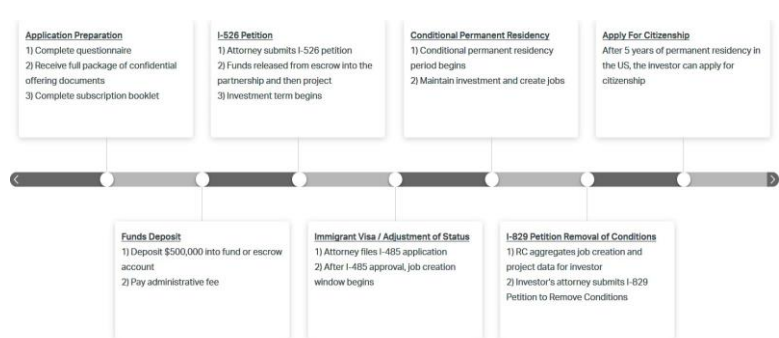
